## Ordinance 2015-23

BE IT ORDAINED by the President and Board of Trustees of the Village of Northbrook, County of Cook and State of Illinois THAT:

### **An Ordinance Amending Chapter 13 of the Northbrook Municipal Code (1991), as Amended, Regarding Regulation of Mobile Food Service Establishments**

shall be, and is hereby, adopted as follows:

#### Section 1. BACKGROUND.

The Communication and Legislation Committee of the Board of Trustees for the Village of Northbrook has recommended that certain standards regarding the licensing of mobile food service establishments ("*MFSEs*") be amended to help protect the health, safety and welfare of citizens within the Village. The amendments to the Village of Northbrook Municipal Code (1991), as amended ("*Municipal Code*"), set forth in this Ordinance and are recommended for adoption by the Village staff.

The President and Board of Trustees hereby find that the adoption of this Ordinance pertains to the Village's government and affairs and is in the best interest of the Village and the public, and adopt this Ordinance pursuant to the Village's home rule powers.

#### Section 2. AMENDMENT TO CHAPTER 13 OF THE MUNICIPAL CODE.

Chapter 13 of the Municipal Code, entitled "Food," shall be, and is hereby, amended as follows:

A. 13-51 Location restrictions.

\* \* \*

(d) Minimum Distance from Special Events: Notwithstanding any other regulation in this Article IV, if the village issues a special event permit for any fair, carnival, circus, festival, special event, or civic event to be conducted in the Village Green Overlay District, as defined in the Village's Zoning Code, the operation of MFS's will be limited to the following areas during that event:

1. Events Conducted in the Village Green Park: Notwithstanding any other regulation in this Article IV, a MFSE may not only serve, dispense, or sell food or beverages within five hundred (500) feet of the lot line of a property on which any fair, carnival, circus, festival, special event, or civic event that has received a special event permit from the village is occurring on Meadow Road between Cherry Lane and the north side of the bridge extending over the West Fork North Branch Chicago River. MFSE specifically may not serve, dispense, or sell food or beverages on Walters Avenue between Lorenz Drive and Spruce Street.
  
2. Events Conducted Elsewhere within the Village Green Overlay District, A MFSE may only serve, dispense, or sell food or beverages on Meadow Road between the bridge extending over the West Fork North Branch Chicago river and Walters Avenue.

~~This prohibition~~ These restrictions may be waived if the operator of the MFSE has obtained written consent of person issued the special event permit to operate ~~within this minimum distance~~ outside of these restricted areas. A copy of such written consent shall be maintained in the MFSE for review upon request by any Village employee or officer.

SECTION 3. EFFECTIVE DATE.

This Ordinance shall be in full force and effect ten days following its passage, approval, and publication in pamphlet form in the manner required by law.
