

Rating Action: Moody's assigns Aaa issuer rating to Northbrook, IL and confirms GOULT debt at Aaa; outlook stable

New York, February 03, 2023 -- Moody's Investors Service has confirmed the Village of Northbrook, IL's Aaa general obligation unlimited tax rating. Concurrently, Moody's has assigned a Aaa issuer rating. This action concludes a review for possible downgrade initiated on November 3, 2022 in conjunction with the release of the US Cities and Counties Methodology. As of fiscal 2022, the village had \$119 million in debt outstanding. The outlook has been revised to stable.

RATINGS RATIONALE

The Aaa issuer rating reflects the village's strong local economy, benefiting from robust resident income and wealth and its proximity to Chicago (Baa3 stable). The village financial profile is robust, characterized by substantial fund balance and available liquidity, material revenue raising flexibility as a home rule municipality and strong policies governing minimum reserve levels. Long-term leverage is above average but not expected to grow materially over the near-term given improved contribution practices for single employer pensions plans and a capital plan that depicts a rate of debt issuance similar to its current rate of principal retirement.

The village's tax base is a credit strength and expected to remain strong, supported by healthy levels of resident wealth and income and its location within the Chicago metropolitan region. The village is mostly residential but also maintains a sizeable commercial sector, which has supported strong sales tax revenue performance. Development within the village is ongoing and includes several large commercial projects and numerous single family home and multi residential projects. Unemployment levels within the village are similar to that of the state and nation.

The village closed fiscal 2022 with a sizeable surplus, given the collection of online sales tax revenue and strong state shared revenue. The village is expecting another positive year of operations in fiscal 2023, which closes on April 30. The village's fiscal 2024 budget is not currently available but we anticipate at least balanced operations. The village maintains a number of enterprise funds, which are also fiscally sound. Across all governmental and business type activities, available reserves were about 70% of revenue.

Long-term leverage is above average for the rating category but unlikely to materially grow over the next couple years given improved pension contribution practices and annual debt issuance that approximates the village's rate of retiring existing debt. The village sizes its pension property tax levy to tread water and makes additional supplemental contributions from various other revenue sources, including ambulance fees. The village contributed about 115% of tread water in 2022 and approximately 125% in 2023.

The lack of rating distinction between the Aaa issuer rating and the Aaa GOULT rating reflects the nature of the obligation which is payable from all available funds and the availability of a property tax levy, unlimited as to rate or amount.

RATING OUTLOOK

The stable outlook reflects our view that the village's financial position and long-term leverage will remain stable over the next several years.

LEGAL SECURITY

The village's outstanding general obligation unlimited tax (GOULT) debt is secured by an all available funds pledge as well as a dedicated property tax levy unlimited as to rate or amount.

PROFILE

The Village of Northbrook is located in Cook County (A2 positive) in northeastern Illinois (Baa1 stable), and is a suburb within the Chicago metro area, approximately 20 miles northwest of the downtown Chicago with a stable population of 35,222. The county is the economic and cultural hub of Illinois, and is central to the Chicago metro area, one of the largest metropolitan areas in the United States (Aaa stable). The largest private industry sectors that drive the local economy include finance/insurance, professional/technical services, and health services.
